### **Regulations**

- **Vehicles and trailers must not be parked on the demonstration site.** Once you are set up move the vehicle to the parking area.
- Demonstrations will be allowed to sell only pet-related products and services.
- Demonstrations will be responsible for providing their own canopies, tables, chairs, extension cords, power bars, and anything else required to operate their demonstration. Limited hydro hookups will be available and must be requested on the Registration form below.
- Demonstrations must leave the site in a clean condition before departing.
